County Executive Graham Stowe asked if there were any corrections or additions to the agenda for said meeting. ADDRESS COMMISSION: STATE REPRESENTATIVE CLAY DOGGETT

State Representative Clay Doggett addressed the Giles County Legislative Body to update on the actions of the General Assembly. He thanked the Commission for their support. He stated the 114th General Assembly will begin the second Tuesday in January. He has served as Chairman of the Criminal Justice Subcommittee and he served on the House Local Government Committee.

He mentioned that there were Public Safety Grants for rural areas for Volunteer Fire Departments, Rescue Squads, and EMS. He stated that he hoped these programs would continue for next year. 261 million dollars was added to the Budget for schools.

Doggett stated that they have worked on creative ways to get state tax dollars back to the counties. They maintain the rainy day fund so the state could run for six months if need be without additional revenue, with a goal of having enough to run the state for a year without additional funds.

He added that he had received inquiries about school buses so they are looking at changing the law on the buses phase out time so counties could use them longer.

State Representative Doggett answered commissioners' questions regarding grants and other legislation. He added that he hoped to be back to the Commission before next July, and he invited all to contact his office if he was needed.

Project Updates:

Project BRT– A world class battery recycling operation. 12-20 Acres. A building of 300,000 sf will be constructed. 115 new jobs and a total of \$705M capital investment, 18 MW to 27MW needed. Did Not Submit

Project Zeus – A highly innovative, biodegradable, recyclable home compostable, watertight packaging materials. Must be 60 minutes from a major city. They prefer to lease but will consider brownfield or greenfield sites that will accommodate a building up to 100,000 sf. 35 jobs and a total investment of \$10.5 million. – Did Not Submit

Project A-Pro– Manufacturing iron and steel components for multiple industries. This company is for existing buildings 150,000-200,000 sf only. 50 new jobs, Capital investment of \$20M – Did Not Submit **Site Development Grant Update** – Draft grading plan completed by Barge design and scheduling meetings for review.

PILOT is still working on acquiring approximately 12 acres just east of Exit 14 on the north side of Hwy 64. If successful, they would plan to have a truck stop up and running by end of the first quarter of 2026. We still need to evaluate if we can have a public waste treatment system up and running by then or if PILOT will need to install their own system.

Giles County Archive Director Barbara Nicolson addressed the Commission to invite all to an Open House at the Giles County Archives located at 211 South Cedar Lane. Nicolson added that she had received a \$5000.00 grant for the previous year which enabled her to refurbish one of the rooms and purchase shelving for the room. She has again applied for the \$5000.00 grant and those funds will also be used for shelving.

She stated that we all need to look to the future as the Archive building is filling up with county records. At present, they are working on some of the records from the County Clerk's office.

RESOLUTION 2024-69 To fund an FY 24/25 Capital Project

County Executive Graham Stowe provided the following explanation of said Resolution:

"Resolution 2024-69 is a commitment to recapitalize the EMS cardiac monitors. This issue has received several months of review through the Financial Management Committee, to the Budget Committee, through the Emergency Services Committee, and back to the Budget Committee before coming here today. There are differences of opinion as to whether this purchase must be executed now or delayed until next year, and that's a reasonable thing to debate. I need to say, however, that it's not reasonable for this to be a contentious debate, because the ultimate goal is not controversial - we're tasked with the responsibility to outfit our EMT's and Paramedics with the best equipment possible, and I'm persuaded everyone in this room wants them equipped to provide the best possible lifesaving measures. The floor is open for a motion."

Upon motion of Caleb Savage and seconded by James Lathrop, it was ordered by the Court that said resolution be adopted.

Emergency Management Director Bill Myers addresses Commission

Commissioner David Wamble asked if Bill Myers could address the Commission concerning said resolution and applications for grants.

Mr. Myers explained that they had received a grant for \$55,000.00 and once you receive that grant, you become ineligible to apply for the next one. That grant was for reimbursement for equipment already purchased. He added that as soon as he is eligible to apply for grants for his department, he will make those applications. He answered Commissioners questions about the monitors, the need for them and the reasons for making the purchase now. If replacements are purchased, the old monitors will be sold on GovDeals.
