# William Bradford, United Communications

County Executive Graham Stowe introduced Mr. William Bradford of United Communications, who, along with his team have been working on bringing broadband to the northern part of the county, for customers of the Duck River Electric Membership Corporation.

Mr. Bradford stated that they will start taking orders for fiber internet service so customers will be hooked up and begin receiving service in April. United Communications is scheduled to be completely done with construction by this August.

Investigating this figure with the TN DOL. The underlying calculation shows the Giles County labor force dropped from  $\sim$ 14,750 in 2024 down to  $\sim$ 13,000, or 12%. While we do normally see annual revisions in January, it is generally +/- 500.

### Project Updates:

### MARCH RFIs

Project Palm – a metal forming, plastics processing and tool making company. 50 jobs, \$40M Capital Investment. Need 10–15-acre site to build 175,000 sf building, rail preferred. – Submitted Mines Road property.

Project Factory2Works – zinc powered battery energy storage solution provider. 600 jobs, Total \$250M capital Investment, 15+acres and 300,000+ sf building. 8-12 MW - Did not submit

Project Paula - A food processing company. \$235M investment, 201 jobs. Looking for a location near I-40 east of Nashville. — Did not submit

Site Development Grant Update – Bids were opened on 3/13/25. We received 3 bids ranging from ~\$497K to \$790K. The bids are being reviewed by the project engineer to ensure they are in order. We will then make a recommendation to the state for approval.

Housing Study – We received the completed housing study, which concluded we need 727 new housing units, including 195 for rent, over the next 5 years: 267 for sale in the \$200K to \$300K range. 208 for sale in the \$300K to \$400K range. Data utilized included housing ownership profiles and household income profiles, including current state as well as expected future growth. A community survey was also conducted and was completed by 307 respondents, including 57 UTS students.

Recreational Development in Dan Speer IPS – Savannah Jenkins, Public Health Educator at the Giles County Health Department, made us aware of the Healthy Built Environment Grant from TN Department of Health. It can provide Phase 1 funding up to \$50K for assessment and planning and then Phase 2 funding of up to \$80K for design and construction of a healthy space. The IDB has authorized me to submit a letter of intent by April 15. The completion of an Active Living Workshop is part of the scoring process, and we have missed the window for this round; however, it is only 10% of the overall score.

### Finance Director Beth Moore-Sumners addresses Commission

Finance Director Beth Moore-Sumners addressed the Commission due to the Director of Schools being out of town, concerning said refund. She stated that the county had received the funds, however, it was not fully executed before the term of the grant expired so the state has recalled those funds. Motion on the floor was put to the voice vote of the Court and carried. Matthew Hopkins voted No. All others present voted Aye.

The County Executive, thereupon, declared motion carried and said amendment resolution adopted.

# RESOLUTION 2025-15 Approving the write-off of \$138,834.85 of uncollected taxes from the books of the Giles County Trustee

County Executive Graham Stowe provided the following explanation of said Resolution:

"Resolution 2025-15 is a write-off of uncollected taxes from the Trustee's office. Mr. Risner will correct me if I'm wrong, but my understanding is that uncollected taxes that are over 10-years past due are considered by statute as uncollectible, and therefore must be written off. The write off must be documented by a resolution of the commission. The resolution is sponsored by the Budget Chair, Mr. Rubelsky. The floor is open for a motion."

Upon motion of Matt Rubelsky and seconded by Matthew Hopkins, it was ordered by the Court that said resolution be adopted.

# **Trustee Tony Risner addresses Commission**

Trustee Tony Risner explained that he had gone back in the office books from 1995 to 2011 researching the uncollectable taxes for those years. He stated that most were personal property taxes which were small amounts individually. In order to "write off" these amounts the Commission must give it's approval. Risner added that he plans to make this an annual report for the uncollectable taxes.

Said motion on the floor was put to the voice vote of the Court and carried. All present voted Aye.

The County Executive, thereupon, declared motion carried and said resolution approved.

### **RESOLUTION 2025-16** Committing to fund capital projects

County Executive Graham Stowe provided the following explanation of said Resolution:

- "Resolution 2025-16 also needs an introduction. Over several months the commission has received a number of briefings on several capital projects. Each of these projects has a preliminary scope of work and a rough estimate, and each has previously received unanimous committee approval. But when lumped together these projects amount to over \$20M, which is why in January the Budget Committee started looking at funding these projects, and began discussing the possibility of a wheel tax as preferable to a property tax increase. It was during that meeting that commission support for some of the projects started to waiver. And as I've mentioned previously, I need concrete direction from the commission. The job of the County Executive is to execute what the commission funds, and conversely, to disregard what the commission doesn't fund. So that's the purpose of this resolution to finalize and document the commission's commitment or lack of commitment to move these projects forward. After this decision is made we can get back to the work of deliberating how they will be funded.
- One more introductory comment the resolution is broken down into 4 sections, with each project getting a separate vote. For each project there are 2 possible outcomes ... a yes vote is to fund the project exactly as it was presented in committee ... a no vote is to not fund the project as it was presented. If a majority of the commission votes "no" on any project, I'll follow up with another question, asking the commission whether you want a down-voted project to return to committee for more consideration.
- Are there any questions before I open the floor for a motion?
- The resolution is sponsored by Dr. Lathrop, and the floor is open for a motion."
